# LEGISLATIVE UPDATE

Terry Speiker, Director, Intergovernmental Relations, said that Commissioner Rettman is testifying today at the House Tax Committee on the Environmental Response Fund (ERF). Ramsey County is getting good hearings. Commissioner Reinhardt testified yesterday on All Children Excel (ACE). Bills are moving quickly through the process because Finance Committee deadlines were set one month earlier than usual. Many of the Commissioners have been testifying.

Materials were distributed to the Commissioners, one being an update on the tracking sheet. A second handout was a summary of the County's highest legislative priorities.

# OUTSIDE BOARD AND COMMITTEE REPORTS

Commissioner Reinhardt reported on:

The City of Maplewood's 50<sup>th</sup> year anniversary of incorporation as a city. A proclamation was presented to them from the County.

Commissioner McDonough reported:

On the Youth Summer Employment request. Originally, the County put in a request for \$750,000, and in the beginning, the City of St. Paul had indicated it would support that. Throughout the process, the City came up with its own bill, which has been causing some confusion. The County has been trying to mesh in with that, but it hasn't been going well because the County has taken the position that the Youth Council, the Workforce Investment Board (WIB) and the whole concept of the workforce area and how those dollars flow. The process we are not supportive of is individual carve-out for any organization or community to do specific programming outside the process.

Commissioner McDonough said he met with Councilmember Helgen on several occasions, and who had attended the Youth Council meeting last week. Councilmember Helgen had asked the Youth Council to support a resolution requesting the County and the City to merge their bills and work together on one bill. There is to be a Youth Council meeting next week

so that the County could provide its perspective that we would be fine with moving forward with one bill but would not agree to the requirement that the City is asking that there be an 85% carve out for St. Paul. When Commissioner McDonough met with Councilmember Helgen after the Youth Council meeting, he indicated they would not agree to that before hand.

Commissioner McDonough said he brought this to the Board's attention for any feedback about this approach, and that the Youth Council needs to get all the information to make a good, solid decision about how they would move forward. When he spoke with the chair to explain the situation, he felt the Youth Council, when it agreed to support the request to combine the bills, clearly had indicated and made it part of the resolution, that it would not support the carve-out for any entity or organization on youth programming dollars, but that all those dollars could then go through the process; that we currently have a place to allocate those dollars.

Commissioner Ortega asked what would happen if a bill passes for \$750,000.

Commissioner McDonough said there are four potential bills – the County's for \$750,000, which is an individual carve-out for Ramsey County. Those dollars would be merged only if the City would agree to not ask for legislative language that would carve-out 85% of those dollars. First the City supported; then they came back to say they would support it if the County would agree to legislative language that there would be an 85% carve-out for the City of St. Paul, and only 15% would flow to the Youth Council and WIB for disbursement through the Comprehensive Youth Workforce Employment Program. The City came forward with its own bill when the County would not agree to the 85% carve-out.

Commissioner McDonough said there is also a bill to increase the big pot of Minnesota summer youth dollars, which has been decreased since 2003, putting all the workforce service areas in a difficult situation. The reality is that most of the people in the State would agree that the best solution would be to increase the big pot and get it back up to where it needs to be rather than taking an individual carve-out approach. Minneapolis was successful in getting this individual request last year, which may have stimulated some other individual requests. If the big pot is funded, there is a formula that has been agreed upon by all the workforce service areas on how that money gets disbursed and spread out among the 15 workforce service areas.

Commissioner Reinhardt asked when the Youth Council plans to meet again in order to be certain this is clarified. Youth Council support has to carry a lot of weight at the Legislature.

Commissioner McDonough said he talked with the chair of the Youth Council yesterday, who was going to see what would be the best approach because he felt the same way – he wanted to get this clarified as quickly as possible to eliminate any confusion. A Youth Council meeting is scheduled for Thursday, March 8 at 3:30 p.m. Commissioner McDonough plans to attend and will present the County's position that we would not support any carve-outs. We would accept the City's support in helping move forward in the Comprehensive Youth Summer Programming bill. It is agreed that the need is great, and \$750,000 was picked in trying to be realistic in what the Legislature could be expected to carry as far as an

individual carve-out. The County could work together with the City on what that dollar amount would be if they would agree to work together toward a single bill. Commissioner McDonough got the assessment from the chair that the Youth Council and the questions they asked, that the message they were sending is that they support having one bill but not having individual carve-outs. That was not a part of the language in the resolution that they passed.

Commissioner Carter wanted to confirm that the key issues are where the workforce service area is and where the need for the youth who qualify for these dollars exists, and whether that need matches the manner in which those dollars are allocated. She assumed that would be the City's concern with such a large percentage of young people who qualify for those dollars being in the City. She also wanted to confirm that per our assessment requested by the City last year, a major percentage of those dollars do go to youth in the City of St. Paul. She did not know if that percentage is 85%. No one is questioning that those dollars are needed by those qualifying youth, but that our contention is that we are the service area for the allocation of those dollars and that there should not be a separate process for allocating those dollars. We are all working together with the City and their members of the WIB, the City having 50% of that membership. Together, we should be able to plan and allocate those dollars in one pot as one program that serves the entire area. She asked if that is correct.

Commissioner McDonough responded affirmatively. He thought the City grabbed onto the 85% number because the history has shown that through eligibility requirements and referrals, 85% of the dollars are typically spent in the City of St. Paul, through a process in going out to the community-based organizations asking them for an RFP on best practices in helping to provide services. It is integrated into a comprehensive year-round workforce development program for youth. The summer piece is just a portion of that. Through the Youth Council, that is integrated into the year-round comprehensive program. Eighty-five percent of those dollars are typically or traditionally spent in the City of St. Paul through that process.

Commissioner Ortega reported:

That this has been a week of testimony at the Senate and Met Council on transit and transportation. There was a meeting with the Post Office yesterday, with good news to report. Senior management has approved the operational plan to move out of St. Paul. Phase II is to make that operational in Eagan. This will hopefully be done in the next six months, and would be on track to have the board of governors approve the entire plan. Dakota County is ready to look at the details for the size of the operations, and impact on traffic and infrastructure so they know what the requests are in terms of federal and State levels of government. Ramsey County will provide a presence because it is in our interest to make sure the whole project moves smoothly.

David Twa, County Manager, said it was very good news because it confirms the fact that Ramsey County can move forward on acquisition of the Post Office.

Chair Bennett, for clarification, said the Post Office purchased the Union Depot Concourse and all the land around the Concourse, which is needed for the transit hub. That is how those two projects inter-relate.

Commissioner Ortega said the entire County Board has been engaged with the Legislature, putting in many hours, and he felt that Ramsey County would do very well. He has received many comments about Ramsey County.

## BOARD CHAIR UPDATE

## Chair Bennett reported:

On newspaper articles for some of the activities he has been involved in related to light rail. More support has been cemented for the multi-modal transit hub at the Depot. The Met Council voted against the "loop", but put into the motion that they would look at the Concourse Level, which is a small victory.

Commissioner Reinhardt said the County achieved a huge victory for the Depot. Gaining attention and getting people to understand how important the Union Depot and Concourse is, that streets will be closed partially or completely, and how the County has to deal with all the issues, the discussion of the group made all those things come to the surface, and that was not a small victory.

Chair Bennett said he explained to that group that the County had a way in to the Concourse Level with the loop; it is now their turn to come up with a way in to the Concourse Level. He had explained to them that they are the planning agency with the charge to have a vision for the whole area for the future.

Commissioner McDonough said Chair Bennett did a great job engaging the community. One role of an elected official is be creative and look to the future, and to make sure that policy decisions being made position us for the long-term good of the community. The loop proposal brought forward by Chair Bennett was that forward creative thinking to make sure that all options would be considered with engagement of the broad-based community of who was weighing-in and who was looking at that, and the excitement generated around that. Action by the Met Council for the loop may seem dim right now, but there should be hope for it. As Commissioner Reinhardt pointed out, there are some big issues with the Cedar Street alignment and how it connects into the Union Depot, and that was brought forward to the surface that these are issues that need to be dealt with – those are huge victories, not small victories.

Chair Bennett said it is the public who will suffer and he does not believe that everyone is attuned to the fact that two streets are going to be closed.

He thanked the former Ramsey County appointees to the Board of Directors of the Community Action Partnership of Ramsey and Washington Counties for their service. New appointments have been made to this partnership.
