

AIR QUALITY PERMIT NOTICE
Cash Creek Generation, LLC - Source I.D. 21-101-00134
Construction and Operating Permit V-07-017

Subject to Prevention of Significant Deterioration (PSD) and Concerning the Construction and Operation of an Integrated Gasification Combined Cycle (IGCC) Combustion Turbine Station, Synthesis Gas-Fired, for electricity production in Henderson County, Kentucky

The Cash Creek Generation, LLC (Erora Group, LLC) of 4350 Brownsboro Road, Suite 110, Louisville, Kentucky has applied to the Kentucky Division for Air Quality for a Title V permit to construct and operate an electric generation station to be located at Kentucky State Highway 1078 in Henderson, Kentucky. The IGCC facility, an air separation plant, a coal gasification facility, and a combined cycle power generation facility are integrated into a single highly efficient electric generation station to produce electricity from synthesis gas. The plant is classified as a Title V major source due to its emissions of regulated air pollutants and hazardous air pollutants. Air quality regulations for prevention of significant deterioration of air quality that define increments of allowable air quality degradation will apply. Increment consumption has been predicted by EPA approved dispersion models to be as follows:

Comments should be sent to Mr. James Morse at the above Frankfort address. To be considered, any written comments must be postmarked within 30 days following the date of publication this notice. All relevant public comments received by the Division for Air Quality will be considered in preparing the proposed permit and submitted to U.S. EPA for a 45-day review.
