**Relevancy of Documents to be Subpoenaed**

It has recently been discovered that the Dept. of Commerce had Comments from the EPA and U.S. Army Corps of Engineers on the Mesaba Project EIS prepared jointly by DOE and Commerce which were withheld from the public for over one month, and which were not discovered until March 13, 2008, after the public's Comment period had passed and the record had closed. The EPA and U.S. Army Corps of Engineers Comments were not entered into the record in the above docket. These Comments call into question the Mesaba Projects stated purpose, alternatives proposed, and impacts of the project, all relevant – the fundamental issues -- in this siting docket.

This request is for copies of all records, notes, correspondence, letters, emails and other communication regarding the Environmental Impact Statement for Excelsior Energy's Mesaba Project between the Dept. of Commerce and the federal Environmental Protection Agency and the U.S. Army Corps of Engineers and any other federal agencies, including any and all of their multiple offices and representatives.
