Relevancy of Testimony

The law requires that to be an "Innovative Energy Project," a project meet three statutory criteria, one of which requires that the IRR Commissioner certify that the "site that has substantial real property with adequate infrastructure to support new or expanded development." The relevant statute is below:

216B.1694 INNOVATIVE ENERGY PROJECT.

Subdivision 1. [DEFINITION.] For the purposes of this section, the term "innovative energy project" means a proposed energy generation facility or group of facilities which may be located on up to three sites:

 that makes use of an innovative generation technology utilizing coal as a primary fuel in a highly efficient combined-cycle configuration with significantly reduced sulfur dioxide, nitrogen oxide, particulate, and mercury emissions from those of traditional technologies;

(2) that the project developer or owner certifies is a project capable of offering a

long-term supply contract at a hedged, predictable cost; and

(3) that is designated by the commissioner of the iron range resources and rehabilitation board as a project that is located in the taconite tax relief area on a site that has substantial real property with adequate infrastructure to support new or expanded development and that has received prior financial and other support from the board.

Minn. Stat. 216B.1694, Subd. 1(3) (emphasis added).

Excelsior's PPA application is replete with references of infrastructure needed, including millions of dollars worth of rail line, Scenic Highway 7 to be moved and deemed the "plant access road," a natural gas pipeline, pipelines for potable water and up to 6,500gpm of process water, wastewater treatment facilities and discharge pipeline network, transmission interconnection and network system upgrades.

The Commissioner's testimony is necessary to establish the basis for her Certification, including knowledge of Excelsior's preferred West site and the basis for the Certification, which goes to the legitimacy of the Certification and whether the West site meets the statutory criteria for an Innovative Energy Project.
