BACKGROUND

On January 12, 2009, Petitioner, Public Service Electric and Gas Company ("PSE&G" or "Petitioner") filed a petition and thirteen testimonial exhibits marked Exhibits P-1 through P-13 with the New Jersey Board of Public Utilities ("BPU" or "Board"). On March 12, 2009, the Board issued a Prehearing Order, which included a procedural schedule.

On April 20, 2009, the Fredon Township School District, Willow Lake Day Camp, and the Township of Parsippany-Troy Hills requested that the Board extend the Last Date for Discovery Requests on Initial Testimony from May 15, 2009 to June 15, 2009.

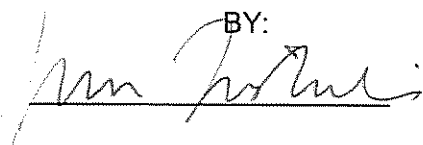
On May 6, 2009, PSE&G filed a response stating that they were willing to consider a two-week extension for discovery, but not the four-week extension sought by Interveners. PSE&G's expressed concern with the entire procedural schedule being delayed.

DISCUSSION and FINDINGS

In light of the pending escrow motions and to provide a complete opportunity for discovery for all of the Interveners, I **HEREBY AMEND** the procedural schedule as described below. The initial procedural schedule was developed to set an overall timeframe for the Board's final decision but that schedule was and continues to be subject to modification as necessary and appropriate. However, the overall procedural schedule that contemplates Board action in December 2009 remains the same.
