Dear Dr. Haar:

Northern States Power Company, a Minnesota corporation ("Xcel Energy" or the "Company") submits to the Minnesota Public Utilities Commission (the "Commission") this Annual Report on our service quality performance for the year 2009. We submit this report pursuant to our service quality tariff (the "QSP Tariff") that establishes performance thresholds for seven customer service measurements and in compliance with the Commission's May 2, 2008 and September 2, 2009 ORDERS, in the above-referenced Docket. This Annual Report includes supporting information regarding our 2009 performance in a series of attachments.

A. Tariff Plan Performance

1. 2009 Performance

This is our sixth Annual Report under our QSP Tariff. We filed preliminary year-end performance data in our monthly report submitted on January 25, 2010 in this Docket. The information in this Annual Report includes any adjustments resulting from our final review of all year-end service quality data. The table below summarizes our 2009 performance.

B. Under-Performance Payments

1. Payment of 2009 Customer Outage Refunds

In accordance with the QSP Tariff, we compensated customers who experienced service levels below established standards for outages unrelated to storm days or public damage. The QSP Tariff service level requires a \$50.00 credit for customers experiencing six or more outages in 2009, or experiencing an outage lasting 24-hours or longer.

On February 25, 2010, we began applying credits to eligible customer accounts for instances when our performance did not meet these service standards. We applied credits to 1,543 customers who experienced six or more service outages during 2009, and credited 565 customers for outages lasting 24-hours or longer. We sent

each eligible customer a letter of explanation prior to the date we applied credits to customer accounts.

2. 2009 Potential Under-Performance Payments

The under-performance payments, as outlined in the QSP Tariff, adjust either upward or downward, based upon the previous year's metric performance. Specifically, Section 1.9 B of the QSP Tariff states:

If the Company's performance on an individual measure requires no under performance payment to be assessed, the next year's potential under performance payment amount(s) will be reduced for that individual measure as follows, but not below the \$.5 million for each performance measure.

Section 1.9 F QSP Tariff goes on to state:

This Settlement Agreement and the associated penalties will expire following the 2008 performance year, unless a new or revised SQP has not been negotiated to replace the plan, in which case this plan and associated penalties will remain in effect until a new or revised SQP is completed.

In 2010, we met all performance standards under the QSP Tariff and did not trigger any under-performance payments. In addition, the total amount of Customer Outage Refunds we paid for 2010 performance did not exceed \$500,000. We not that we are currently in the process of renegotiating new standards with Commission Staff, the Minnesota Office of Energy Security, and the Minnesota Attorney General-Residential Utility Division. Because this process is not yet complete, we provide below the maximum under-performance payments for our 2010 performance under the current QSP Tariff:

^{*}The payment for any metric cannot decrease below \$500,000 therefore the ratchet is reduced or eliminated.

D. OMS Audit

On July 1, 2008, Davies Consulting Inc. ("DCI") filed its Final Report and recommendations from their review of our Outage Management System ("OMS"). In Compliance with the Commission's September 2, 2009 ORDER in this Docket, we outline below the steps we have taken, as well as our future plans to implement the recommendations contained in the DCI Final Report.

We provide below updates that have occurred since our October 1, 2009 Compliance Filing in this Docket.

1. Training, Data, Outage Management System Software, and Mobile Data Terminals

Order Point A: Improving training, data adjustment, storm normalization, and customer count processes; upgrading its OMS software, and placing Mobile Dispatch Terminals in all service trucks.

a. OMS Upgrade

The planned OMS upgrade that we noted in our October 1, 2009 Compliance Filing in this Docket is now scheduled to be complete in the first quarter of 2011. However, we are examining whether it may be more prudent to wait until the next software version is available to upgrade. While waiting for the pending software version would push our implementation to the 3rd quarter of 2001, it would enable greater functionality, and also ensure we have continued vendor support. We expect to make our upgrade decision in July 2010.

b. Mobile Data Terminals

As noted in our October 1, 2009 Compliance Filing in this Docket, we are not planning to expand MDT usage at this time. However, we have updated all existing MDTs that generally gives employees greater ability to send and receive data in the field.¹

2. Leveraging OMS Data

Order Point B: Develop programs to reduce future outages, improve customer reliability, and improve crew efficiency, including enhanced use of Geospatial

Information System data, identification of customers and areas experiencing frequent outages, and use of AMR data.

a. Quality of Service

We continuously work to improve the quality of our service, such as outage restoration duration, and crew efficiency. Some of these initiatives take the form of capital investments.

In addition to the "Intelli-team" equipment we discussed in our October 1, 2009 compliance filing in this Docket, we also installed Trip Savers in 2009. Trip Savers are small reclosers that will open a faulted circuit and reclose once to restore service to the affected customers. The end result is a momentary, rather than a sustained outage. Typically, the customer would only be out of electric service for several seconds, rather than several hours. We are in the process of reviewing the data generated by these devices, which we will use to determine whether further investment and deployment is appropriate for our customers and the Company.

3. Resources

Order Point C: Dedicating adequate resources to assure and enhance data integrity, regulatory reporting, and systems and processes.

We have no updates from our October 1, 2009 Compliance Filing in this Docket

Security Data

The raw reliability data provided with this filing includes "security data" as defined by Minn. Stat. § 13.37, subd. 1(a). Xcel Energy believes that some of the raw data on the disks and/or that has been eFiled could be manipulated to reveal the location and size of certain facilities that have been summarized in the Monthly Report. The public disclosure or use of this information creates an unacceptable risk that those who want to disrupt the electrical grid for political or other reasons may learn which facilities to target to create the greatest disruption. For this reason, pursuant to Minn. Stat. § 13.37, subd. 2, we have excised this data from the public version of our filing.

We appreciate the opportunity to present this information for the Commission's consideration. We have served copies of this Annual Report on all Parties on the attached service list.
