

7849.0255 INDEPENDENT POWER PRODUCER LEGF

APPLICATION. An independent power producer proposing an LEGF shall provide relevant data in the following manner.

Subp. 1. Applicant data. Independent power producers shall provide the following information about the applicant:

A. legal name;

B. state of organization or incorporation, as applicable;

C. principle place of business;

D. the name of the individual or entity that owns and controls, directly or indirectly, a majority of the then outstanding voting securities of the applicant or, if no one individual or entity so owns and controls such a majority of voting securities of the applicant, then the names of the individual(s) and/or entity(ies) that own and control collectively, directly or indirectly, a majority of the then outstanding voting securities of the applicant.

~~Subp. 12.~~ **Utility data.** If the applicant has entered into a power purchase agreement with a utility serving end user customers, the applicant must provide the data required under part 7849.0250 and parts 7849.0270 – 7849.0300 from the utility for the proposed facility.

~~Subp. 23.~~ **Relevant available data.** If the applicant has not entered into a power purchase agreement with a utility serving end user customers and does not have access to the data required under part 7849.0250 and parts 7849.0270 -.0300, the applicant must provide the following:

A. data on regional capacity with a description of the data source relied upon and the time period covered by the data;

B. the regional availability of renewable resources and the source relied upon for the data;

C. for a proposed renewable LEGF intended to satisfy renewable energy standards, planning studies relied upon by the applicant to demonstrate the need for renewable generation to meet those standards;

D. alternative approaches for supplying the energy;

E. impacts on Minnesota ratepayers; and

F. evidence of the facility's ability to maintain electric system reliability.

Subp. ~~34~~. **Subsequent Power Purchase Agreement.** An applicant who enters into a power purchase agreement with a utility serving end user customers after filing an application under this Chapter and prior to certification of the facility shall immediately file a copy of the agreement with the commission and the department.

Subp. 5. **Subsequent Changes in Applicant Data.** In the event any of the information provided in subpart 1 changes during the period following the date that the facility has been certified and prior to the date the facility is placed into service, then the applicant shall provide the commission with notice no later than 30 days following such change. Notices provided under this subpart are not subject to review or recertification by the commission.
