Hi Jamie,

thanks for your voice mail and your maps/letters. I have a meeting with Black Oak today - so that is very helpful. Currently (from an eagle standpoint) I have asked them to consider removing turbines 38 and 14, as they sit in a flight path between two wetlands and there is an eagle nest near them. I have attached a map so you can get a visual. I have asked the consultants to overlay their flight path data for eagles and other birds (if they have other birds?) with the proposed turbines, and hopefully that will give us a better idea of problematic turbines. I want to support the DNR's recommendations too, so I am hoping the flight path data will give us more information. I also want to talk to them about possible curtailment of some turbines - one of my main concerns with this project is the huge amount of seasonal waterfowl that passes through here.

Thanks for passing on your recommendations to us.
