Hey Mags,

When you switched to the GOEA run, there was only one 'season' (aka strata), which was the time of year when you expected GOEA might have some chance of being present. The AddTot<-TRUE or AddTot<-FALSE line just tells R to either add the strata or to not add them... if you only have 1 strata, then there's no need to add it.
