This is to inform the Commission that, due to Enbridge Energy's recent announcement regarding the Dakota Access Pipeline Project and uncertainty as to the timing of its proposed projects, the Department of Commerce will not be submitting an EIS Scope Decision Document for the proposed Sandpiper Pipeline Project or the Line 3 Replacement Project on the schedule we had earlier indicated to Administrative Law Judges LaFave and O'Reilly. The Department will put in abeyance the filing of the Sandpiper and Line 3 Replacement Project Scope Decision Documents until such time as Enbridge makes clear its intentions about the projects, or until we receive further direction from the Commission.

As always, the Department is available to answer any questions the Commission may have in this regard.
