(Minnkota) has received a formal request from North Dakota Pipeline Company LLC (NDPC) to withdraw our Route Permit Application for the referenced project with the Minnesota Public Utilities Commission (PUC). Since NDPC has petitioned to withdraw their applications associated with the pipeline project (PUC Dockets PL-6668/CN-13-473, PPL-13-474) that Minnkota's transmission line would have provided electrical power to, the transmission line for that specific load is not needed at this time. PETITION TO WITHDRAW HVTL ROUTING PERMIT APPLICATION

I. INTRODUCTION.

Minnkota Power Cooperative, Inc. (Minnkota) hereby respectfully petitions the Minnesota Public Utilities Commission (PUC) to withdraw its application for an HVTL route permit for the Clearbrook to Clearbrook West 115 kV HVTL and New Substation project pursuant to Minn. R. 7829.0430.

II. DISCUSSION OF WITHDRAWAL

Minnkota has determined, based upon a request from North Dakota Pipeline Company LLC (NDPC), that it will no longer pursue the regulatory approvals necessary to construct the Clearbrook to Clearbrook West 115 kV HVTL and New Substation. Accordingly, Minnkota submits this Petition pursuant to Minn. R. 7829.0430 to withdraw our HVTL route permit application (RPA).

Minnkota requests that the PUC approve the Petition because Minnkota is entitled to withdrawal its application as a matter of right. Furthermore, it would not be prudent to continue the RPA approval efforts for all parties involved due to our withdrawal request.

III. MOTION TO WITHDRAW HVTL ROUTE PERMIT APPLICATION

Minnkota moves that the PUC withdraw and suspend efforts on our RPA for this project (ETL/TL-14-665) and act on this Petition as soon as possible.

IV. RESPONSE TO PETITION AND MOTION

Pursuant to Minn. R. 7829.0430, persons opposing the Petition have 14 calendar days from the date of service to file objections.

V. CONCLUSION

Minnkota respectfully requests that this Petition to Withdraw be granted.
