Short Elliott Hendrickson Inc. (SEH®) submitted Permitting Documents to the Minnesota Pollution Control Agency (MPCA) dated June 15, 2016, for the proposed Lab USA's Ash Processing Facility – Red Wing. In an email dated October 18, 2016, you provided a draft permit for our review in preparation of the upcoming public notice. Since the June submittal, a few details have been modified that appear to require an amendment to the Permitting Documents.

On behalf of Lab USA Corp., SEH is providing an amendment to the original Permitting Documents (SEH, June 15, 2016). Each modification is described below:

Section 1. List of Permittees

Since submittal of the Permitting Documents, the Lab USA offices have moved. Please correct the Permittee activity owner and Permittee operator address as follows:

Section 2. Permitted facility description

Since development of the conceptual design that was included in the Permitting Documents, Lab USA has been considering different equipment layout scenarios. The original Permitting Documents included a 27,500 square foot building. Lab USA would like to increase the dimensions of the building to approximately 30,000 square feet to provide the option of more indoor storage. Please revise the reference to the 27,500 square foot building to an approximate 30,000 square foot building.

Also note that although not specifically referenced in the Draft Permit language, the height of the facility may increase from 35 feet to about 42 feet to accommodate operation of a crane for equipment placement.
