Governor Tony Evers

Governor, as Mayor of the City of Hudson I am requesting that you send members of the National Guard to Hudson today. I believe there is a credible threat to the safety of our City, our residents and our businesses. I know you are monitoring what is happening immediately across the border from us. St. Paul is just 15 miles from Hudson. Minneapolis is 20 miles from us. Looting has actually taken place within ten miles of Hudson.

Minnesota's Fusion Center has alerted their state that 70,000 to 75,000 agitators are traveling today from locations such as Kansas City, Chicago, Ohio and other parts of the country to the Twin Cities. They are mostly traveling by road and will be passing right through Hudson to get to St. Paul/Minneapolis. The City of Hudson is the last set of exits before entering Minnesota meaning that it is very likely a number of these agitators will be stopping in our community on their way to Minneapolis. That same intelligence has learned that the organizers are directing members of their group to instigate unrest in surrounding areas. All of our surrounding communities (cities, towns and counties) and their respective Law Enforcement departments are anticipating and girding for significant trouble tonight.

Indeed, Minnesota Gov. Walz has activated the entire complement of the Minnesota National Guard acting upon the aforementioned Fusion Department intelligence. For the FIRST time in their long history the ENTIRE force is being called upon to respond to this anticipated threat.

Governor, this is a dire situation we are facing today and tonight. I do not make this request lightly. I believe that if we are to err that we err on the side of keeping all the members of our communities safe. That responsibility is paramount – the safety of our people. I implore you to please send us help.
