Hearing Information

Under Minnesota Statute § 216E.07, the Commission is required to hold an annual public hearing to afford interested persons an opportunity to be heard regarding any matters relating to the siting of large electric generating power plants and routing of high-voltage transmission lines.

The Honorable Ann O'Reilly, Administrative Law Judge with the Office of Administrative Hearings, will preside over the hearing and will provide the Commission with a written summary of the hearing after the close of the comment period.

At the hearing, staff from the Commission and the Department of Commerce will provide an overview of the program including a summary of projects initiated, pending, and permitted in 2021. Interested persons will have the opportunity to: (1) ask questions of agency staff; and (2) offer oral and written comments into the record. In addition, written comments may be submitted during the comment period following the hearing using the methods described in this notice. The hearing will end when all attendees have had the opportunity to comment, and all other business has been concluded. Please note that no comments or questions on specific projects or dockets will be considered at the annual hearing.
