- 2. Stephanie Elsen requested to begin working on putting together a Marketing Plan.
- B. Finance Committee (Stephanie, Ron): The Finance Committee met May 18th to discuss the following items:
- 1. 2017 Budget Timeline, Capital Improvement Plan (CIP) Currently we have the transient dock project in the CIP for \$4,000,000, which the City is managing. The Finance Director reiterated to me the City only wants items in the CIP that we are seriously considering doing in the next 10 years. The committee agreed there are no additional items to add to the existing CIP and recommended to not make any changes at this time.

- 2. The Finance Director also updated me on the possibility that the City may experience a higher Market Value for 2017 due to Xcel Energy continued capital investment in their facilities in Red Wing. It was suggested that the Finance Committee may want to consider raising the base levy amount by 2.5 %. In the last three years Red Wing has seen Market value increases of 10% (information item).
- 3. Finalizing the Riverbend Loan- Riverbend Coop had a loan with the Red Wing Port Authority effective March 1, 2012. The loan went into default as of January 2014. In addition Southern Minnesota Initiative Foundation (SMIF), also had a loan with Riverbend. Both entities have a shared first position on assets for the company and have been trying to sell off the assets and dividing the proceeds between us. I have been in dialog with the Finance Department regarding the best way to proceed regarding the write-off of the loan. At this time I am coordinating efforts with SMIF to have the remaining items picked-up and auctioned off. Once the final sale has taken place I will come back to the Finance Committee for permission to write-off the loan.
- 4. Recommendation for Red Wing Firearms and Gun Range.

Motion to Approve the Finance Committee's recommendation to not sell property located at 250 Highway 19 (former Central Research Building and surrounding area totaling of 4.5 acres) at this time due to a lack of financial information provided by Red Wing Firearms and Gun Range.
