Minnesota Public Utilities Commission

The Commission's Role



- The Commission regulates three service industries in Minnesota's economy electricity, natural gas and telephone.
- The Commission consists of five commissioners appointed by the governor to six-year, staggered terms. Commission staff consists of approximately 50 permanent full-time people.



• The Commission is responsible for ensure electric adequacy, reliability and efficiency. The Commission regulates investor-owned utilities to ensure Minnesotans are charged reasonable rates for power.

PUC Energy Facility Permitting



- The Commission has the authority to issue permits for construction and operation of energy generation facilities and transmission lines.
- Commission staff review evidence, build a record of information, analyze the information, and make recommendations to the five Commissioners who have final say about a given permit decision.
- The Commissioners, after collecting information from the public and interested parties will make the final decision about a project, which carries the weight of law.

Meeting Purpose

Provide information about:

- The proposed project;
- The state's high-voltage transmission line routing permit process.

Provide an opportunity to participate in developing the scope of the Environmental Assessment.

This includes:

- Commenting on potential impacts of the proposed project;
- Commenting on methods to minimize, mitigate, and avoid potential impacts;
- and proposing alternative routes and route segments for consideration.

Permits Required

The proposed project is a **High-Voltage Transmission Line (HVTL)**. In order to construct the project, Minnesota Power must first obtain two permits from the Public Utilities Commission.

A **route permit** is required because the transmission line has a rating of greater than 100 kilovolts and is greater than 1,500 feet in length.

A **certificate of need** is also required for the project to demonstrate a need for the energy from the project and determine its size, type and timing.

Decision Criteria

In determining the route of a high-voltage transmission line, the Commission must consider the characteristics, the potential impacts, and methods to minimize or mitigate the potential impacts of all proposed routes so that it may select a route that minimizes human and environmental impact. Specifically, the Commission must consider impacts on the following:

- Human settlement
- The natural environment and natural resources.
- Historical, archaeological, and culturally significant resources
- Existing land use and economies
- Project cost and accessibility
- Sharing or paralleling existing rights-of-way
- Extent to which construction, cleanup, and restoration practices are mitigated through regulatory conditions
- Cumulative potential effects of related or anticipated future pipeline construction
- Relevant applicable policies, rules, and regulations of other federal, state, and local agencies








HVDC MODERNIZATION PROJECT

Objective analysis of the project

- Evaluate potential human and environmental impacts
- Identify strategies to avoid, minimize, or mitigate impacts
- As a neutral third party, we not advocate just the facts
- Goal is informed decision-making

Scoping - What should the EA include?

Public input focuses the EA on the most relevant information needed to make informed decisions.

 - Specific permit conditions
 - Unique characteristics in the project area


