Post election Complaint -- no need for an expedited probable cause hearing.

A Complaint was filed on September 11, 2024, alleging Gary locco, locco for Red Wing Mayor, RRJ Redwing LLC, and Wilson Oil Co. violated provisions of Fair Campaign Practices and Finance Acts regarding a rooftop campaign sign in Red Wing on behalf of the campaign Gary locco for Red Wing Mayor. See OAH 21-0325-40299. A sign lease of \$1.00 was reported as of the August 4, 2024 Report, and locco is acting as his own campaign treasurer. Based on that Complaint, prima facie violations of Minn. Stat. §211A.02 and Minn. Stat. §211B.15 were found, and the matter proceeded regarding those prima facie violations. Complainant Overland withdrew the Complaint as regards Wilson Oil Co., as Wilson Oil was not a party signing the lease, as disclosed by locco the evening before the October 1, 2024 hearing. locco for Mayor and Wilson Oil Co. were dismissed on October 8, 2014, without prejudice, when Complainant Overland and Respondent RRJ Redwing, LLC failed to appear for the leaving Dehn Oil Co./RRJ Red Wing LLC as the remaining Respondent. A settlement was reached on October 14, 2024 between Respondent Dehn Oil Co./RRJ Redwing, LLC and Complaint Overland, shortly after the Probable Cause hearing on that same day, and within hours of the settlement, the rooftop sign was removed. Complainant withdrew the Complaint against Dehn Oil Co./RRH Red Wing, LLC that same day. locco has not filed an amended Report nor has he filed any subsequent report showing a market rate disbursement or contribution for the rooftop sign.

The issues raised in the September 11, 2024 Complaint regarding Gary locco and Gary locco for Red Wing Mayor regarding the rooftop sign on display for two and one-half months, locco and his campaign's acceptance of that significant corporate contribution, and the prima facie determination have yet to be substantively addressed as to locco's participation, hence this Complaint.


Complaint - Violation of the Campaign Finance and Fair Campaign Practices Acts

To the Office of Administrative Hearings:

Attached please find this executed Complaint for Violation of the Campaign Finance and Fair Campaign Practices Acts, \$50 filing fee, and attachments with specifics of the Complaint.

This Complaint is regarding the campaign of Gary Iocco for Mayor, and is focused on display of a very large Gary Iocco for Mayor sign along Highway 61/Main Street, an acceptance of a prohibited corporate donation in a very prominent location in Red Wing:





The specific statutes at issue are:

Minn. Stat. §211A.02 Must submit financial reports for contributions Minn. Stat. §211B.15, Subd. 2(b) – Prohibited acceptance of corporate contribution

Seeks civil penalty, forfeiture, & referral to county attorney. Minn. Stat. §211A.06; Minn. Stat. §211A.09, Subd. 3; Minn. Stat. §211B.17, Subd. 1 as amended; Minn. Stat. §211B.15, Subd. 4.

Date(s) of violation(s): Beginning July 19, 2024 through removal of sign on October 14, 2024, essentially three months.

Date of election or ballot question: November 5, 2024

Gary Iocco is a candidate for Mayor of the City of Red Wing, a local candidate as defined by Minn. Stat. §10A.01, Subd. 10d. Iocco filed his initial Campaign Financial Report dated August 5, 2024, attached. Minn. Stat. §211A.06 Failure to Keep Account.

Gary Iocco is not new to campaigning and knows or should know Campaign Finance law. Prior to this run for Mayor, he ran for state House district 28A, losing to Sandy Wollschlager. In 2002, he ran for state Senate, losing to Steve Murphy. He also served 3 terms on his Township Board and one term as Goodhue County Commissioner. When filing for a city race, candidates are provided with a notebook of regulations and statutes that must be followed. He would have filed multiple Campaign Finance Reports for these state and county races.

Iocco reported the following disbursements on his August 5, 2024 Report, including "7/26/24 Sign Lease \$1.00." Exhibit A, July 19, Lease.

This very large Gary Iocco for Mayor sign was displayed on a roof, as above, with two lights during the night, clearly visible from Hwy 61, the main thoroughfare through Red Wing (as above photo). The lease was dated July 19, 2024, and extended until October 14, 2024 when it was removed.

This sign location is on a roof in an area comprised of several parcels, all owned by RRJ Redwing, LLC: Goodhue County GIS https://maps.co.goodhue.mn.us/Red%20Wing%20TPV/), a corporation as defined in statute. Ex. D – Ownership information.



FULL DISCLOSUE: After a probable cause hearing October 14, 2024, a settlement was reached between Complainant Overland and Dehn Oil Co./RRJ Redwing, LLC, the recorded owner of Tax Parcel ID: 556400120, on which the sign was displayed (RRJ Redwing, LLC, John Dehn, Dehn Oil Company, 6735 141st Ave N.W., Ramsey, MN 55303-5727). The sign was immediately removed the morning of October 14, 2024. Complainant requested withdrawal that same morning, and the Order of Dismissal was filed on October 16, 2024.. OAH 21-0325-40299.

Gary Iocco, Gary Iocco for Red Wing Mayor, is the remaining party whose alleged violations of campaign law have not yet been addressed beyond the prima facie determination of September 20, 2024.

The most obvious violations of the Iocco campaign are of Minn. Stat. §211A.15 prohibition of corporate donations. In this case, there was a significant corporate donation of the use of the RRJ Redwing/Dehn Oil Co. building roof for a large campaign sign, where the total corporate contribution was not disclosed. Another violation is that the "\$1 lease" is far below fair market value for a large, lighted, and heavily trafficked location. Id., Market Rate of various locations from Reagan Signs (see yellow highlighting); Ex. D, Traffic Mapping from DOT.

Based on Ex. C, Reagan Sign Market Rate quote (see yellow highlighting), considering the sign sizes and traffic counts on which they base the monthly rate, and the range of monthly rates, and considering the DOT's traffic shown in Ex. D, Red Wing Traffic Mapping for that location, it appears a ballpark market rate for the Gary Iocco for Red Wing Mayor rooftop sign would be \$320-400 monthly, or \$960-\$1,200 for the three months the sign was displayed. That would mean that by placing the sign, the Iocco Campaign accepted a prohibited campaign contribution

in the amount of \$960-\$1,200 minus the \$1 said paid for the lease, or did not disclose the full payment for the location in Exhibit B, or the cost of the lease was misrepresented in Exhibit A.

Corporate donations are a material violation, with the potential of civil and criminal penalties for responsible candidates and responsible individuals, and also those aiding abetting, and/or advising. Gary Iocco is acting as his campaign's own treasurer on all of the filed Reports. http://red-wing.org/1156/ 2024 He has not amended any of his filed Reports, nor has he filed any report disclosing a disbursement or this corporate donation, despite having had nearly two months' notice provided by the initial complaint of September 11, 2024.
