

INITIAL INFORMATION/DISCOVERY REQUESTS

To Respondent Gary locco – Gary locco for Mayor:

Please provide information and documents via email to Complainant at address below. If you have no knowledge of questions asked, and/or no documents requested, please so state.

- During the telephone Prehearing Conference, before going on the record, and in a later phone call, you stated "When Wilson Oil asked if I want to put up sign..." and repeated Wilson involvement. Please provide the following information:
 - a. Who from Wilson Oil asked if you wanted to put up a sign;
 - b. When and where were you asked about putting up a sign? Provide dates and details.
 - c. Was this matter discussed at 2355 Old West Main?
 - d. What was said in the discussion generally, and specifically in the "ask", regarding whether you wanted to put up a sign.
 - e. At the time of agreement and installation, who/what entity did you believe was the owner of the property where the sign was installed?
- 2. Your campaign Financial Report of August 8, 2024 states that you paid \$800.00 for the sign.
 - a. Where was sign made?
 - b. On what dates was sign ordered, delivered/picked up, and paid for?
 - c. Was the sign paid for at pick-up/delivery, or on receipt of invoice?
- 3. In our telephone call after the Prehearing Conference, you stated that you did not know that Wilson Oil **property** had been sold.

- a. What did you know about the sale of "Wilson Oil" at the time of the discussion about putting a sign up?
- b. Does Mike Wilson have an office at 2355 Old West Main?
- 4. You stated that a lease for the sign was ready to sign.
 - a. Who told you that it was ready?
 - b. Who wrote up the lease?
 - c. How was the \$1 lease payment determined?
 - d. Who all was present at time lease as signed?
 - e. After it was signed, who all was provided with a copy of the lease?
- 5. Were you present when the sign was put up on the roof?
- 6. Regarding installation of the sign:
 - a. Provide names of those putting up sign.
 - b. What equipment was used to put sign up, and where did it come from rental, on-site, or ?
- 7. After the sign was put up, did you have any discussion with Mike Wilson regarding the sign?
- 8. After the OAH hearing on October 14, 2024 and a settlement was reached to remove the sign:
 - a. When and how did you learn of agreement between Overland and Dehn Oil to remove the sign?
 - b. When and how did you learn that the sign had been taken down?
 - c. Who all worked on taking the sign down, by name.
 - d. What equipment was used to take sign down?
 - e. Were you present when the sign was taken down?
 - f. How, who, where, and when was the sign returned to you?
 - g. Was it stored before it was returned, and if so where and for how long?
