RE: NOTICE OF INTENT TO CONSTRUCT, OWN, AND MAINTAIN THE MINNESOTA PORTION OF THE NORTH ROCHESTER - COLUMBIA TRANSMISSION LINE DOCKET NO. ET3/CN-25-121

Dear Mr. Seuffert:

Dairyland Power Cooperative ("Dairyland") submits this notice to the Minnesota Public Utilities Commission ("Commission"), pursuant to Minnesota Statutes section 216B.246, subd. 3(a), that Dairyland intends to construct, own, and maintain the Minnesota portion of the North Rochester -Columbia 765 kilovolt (kV) Transmission Line Project (the "Project") from a midpoint structure on the new 765 kV line from North Rochester to Marion Road (as will be agreed between Dairyland and Northern States Power Company d/b/a Xcel Energy) to the Minnesota-Wisconsin border.

On December 12, 2024, the Midcontinent Independent System Operator, Inc. ("MISO"), a federally registered planning authority, approved its Long-Range Transmission Planning ("LRTP") Tranche 2.1 Portfolio, which includes the Project and associated underlying facilities (as LRTP Project No. 26). MISO designated the majority of the Project in Minnesota—from the Minnesota-Wisconsin border to Marion Road—as an upgrade that will utilize existing right-of-way owned by Dairyland. Accordingly, although that portion of the Project can only be owned and operated by Dairyland and is arguably exempt from the notice requirements of Minnesota Statutes section 216B.246, Dairyland is including it in this notice out of an abundance of caution.

Dairyland is an incumbent electric transmission owner in the state of Minnesota, and the Project connects to and will be built on facilities owned by Dairyland. Pursuant to Minnesota Statutes section 216B.246, subd. 3(a), Dairyland provides the Commission notice that it intends to construct, own, and maintain the transmission line and associated facilities that comprise this Project as described above and plans to file a petition for a Certificate of Need (or request for certification under the Biennial Transmission Report process) within 12 months of the date of this letter.
