ITC Midwest LLC (ITC Midwest) respectfully submits this notice to the Minnesota Public Utilities Commission (Commission), pursuant to Minnesota Statute § 216B.246, subd. 3(a), that ITC Midwest intends to construct, own, and maintain the Minnesota portion of the Lakefield Junction – East Adair 765 kilovolt (kV) transmission line and connected and underlying associated facilities (Lakefield Junction – East Adair 765 kV Project).

On December 12, 2024, the Midcontinent Independent System Operator Inc. (MISO), a federally registered planning authority and regional transmission organization, approved its Long-Range Transmission Planning (LRTP) Tranche 2.1 portfolio of projects as part of its 2024 Transmission Expansion Plan (MTEP24). MISO's LRTP Tranche 2.1 portfolio is made up of 24 projects, including LRTP No. 23, the Lakefield Junction – East Adair 765 kV Project. The Lakefield Junction – East Adair 765 kV Project is designated as a Multi-Value Project under MISO's Open Access Transmission, Energy and Operating Reserve Markets Tariff (Tariff).

ITC Midwest is an incumbent electric transmission owner in the state of Minnesota. Pursuant to Minnesota Statute § 216B.246, subd. 3(a),¹ ITC Midwest provides the Commission notice that ITC Midwest intends to construct, own, and maintain the transmission line and associated facilities that comprise the Minnesota portion of the Lakefield Junction – East Adair 765 kV Project. In accordance with the statute, a Certificate of Need application (or request for certification under the Biennial Transmission Report process) will be filed within 12 months of the date of this letter.
