Fort St., Ste. 1700, Detroit, MI 48226. (313) 963-5553.

NOW THEREFORE,

IT IS ORDERED that any pretrial motion(s) and/or motion(s) in *limine* shall be filed **on or before Wednesday, April 9, 2025**. The opposing party may file a response to any such motion(s) **within seven (7) days of being served with the motion(s)**.

IT IS FURTHER ORDERED that oral argument on any pretrial motion(s) and/or motion(s) in *limine* filed by the above-referenced deadline, will be heard on **Wednesday, April 23, 2025**, commencing at **9:30 a.m.**, at the office of the Michigan Attorney Discipline Board, 333 W. Fort St., Ste. 1700, Detroit, MI 48226. (313) 963-5553.

IT IS FURTHER ORDERED that **on or before Wednesday, April 30, 2025**, each party shall file a witness list and an exhibit list in the following fashion:

1. Witnesses: each party shall provide a list of witnesses who will be called to testify at the in-person misconduct hearing. Only listed witnesses will be permitted to testify at the hearing, except for rebuttal witnesses whose testimony could not be reasonably anticipated, or except for good cause shown; and,

2. Exhibits: each party shall list, with a short identifying description, each exhibit they intend to introduce at trial. Only listed exhibits will be considered for admission at the hearing, except for rebuttal exhibits that could not be reasonably anticipated before trial, or except for good cause shown. **Each exhibit shall be pre-marked in the same fashion, with the exhibits being denominated sequentially: i.e. Respondent's Exhibit [A,B,C,D], or Petitioner's Exhibit [1,2,3,4], etc., and clearly identifying the party offering the exhibit.**

IT IS FURTHER ORDERED that **on or before Wednesday, April 30, 2025**, the parties shall individually file a prehearing statement listing any and all stipulated facts, issues of fact to be litigated, and issues of law to be litigated.
