**In the Matter of the Application for a Certificate of Need for the Iron Range – St. Louis County
– Arrowhead 345 kV Transmission Line Project.**

PLEASE TAKE NOTICE that the Minnesota Public Utilities Commission (Commission) is accepting comments on Minnesota Power and American Transmission Company LLC by and through its corporate manager ATC Management Inc. (ATC) (collectively, the Applicants) request for exemption from certain certificate of need application content requirements for the Iron Range – St. Louis County – Arrowhead 345-kV Transmission Project (ISA Project or Project).

The Project would involve construction of a new, approximately 62-mile-long, single-circuit 345-kV transmission line on double-circuit capable structures from Minnesota Power's Iron Range Substation in Itasca County, Minnesota to Minnesota Power's St. Louis County Substation in Solway Township, St. Louis County, Minnesota. The Project would also require construction of a new, approximately one-mile-long, double-circuit 345-kV transmission line from Minnesota Power's St. Louis County Substation to ATC's Arrowhead Substation in Hermantown, St. Louis County, Minnesota.
