### **Project Information**

Minnesota Power and American Transmission Company (applicants) propose to construct approximately 67.5 miles of 345 kilovolt (kV) transmission line from Minnesota Power's Iron Range Substation near Grand Rapids, Minnesota to Minnesota Power's St. Louis County Substation near Hermantown, Minnesota, with a connection to American Transmission Company's nearby Arrowhead Substation along portions of Itasca and St. Louis Counties. The proposed route is located along, and in some cases replaces, existing high-voltage transmission lines for 92 percent of its length. New transmission lines will be required to connect the existing substations in Grand Rapids and Hermantown. The proposed Project would also include modifications to the Iron Range Substation, St. Louis County Substation, and Arrowhead Substation.

The Project requires a certificate of need (CN) and a route permit from the Commission before it can be constructed. The applicants submitted a joint CN and route permit application on January 5, 2026. The Commission has determined that the joint application is sufficiently complete to begin the review process. ### **Public Meeting Information**

Commission staff will facilitate the meetings. The purpose of the meetings as outlined in Minnesota Rule Chapter 7849 and Minnesota Statute Chapter 216I, include the following:

1. Provide information about the proposed project and the state's permitting process, and present major issues. Commission staff will begin the meeting by presenting information on the permitting and environmental review process. Applicants will provide an overview of the proposed project and the potential human and environmental impacts and mitigation measures to minimize impacts that are presented in the environmental assessment (EA) included in the application.
2. Accept public comments on the scope of the environmental report (ER) that will be prepared by the Commission for this project. The report will include an analysis of the potential human and environmental impacts of the proposed project, as well as those of a no-build alternative and alternatives of a different size or type or with a different timing. To help the Commission determine the projects that it will analyze in the ER, please consider providing information to help answer the following question:

- a. Are there other ways to meet the stated need for the project, instead of the proposed transmission line? If so, what alternatives to the project should be studied in the ER?
3. Accept public comments on the need for and scope of an addendum to the EA included in the application. To help the Commission decide whether it needs to prepare an addendum to the EA, please consider providing information to help answer the following questions:
  - a. Are there potential human and environmental impacts or unique characteristics of the proposed project that are not addressed in the EA prepared by the applicant (see [Appendix E](#) of the joint application)?
  - b. Are there any methods to mitigate potential impacts of the proposed project that require further evaluation?
  - c. Are there any other alternative routes or route segments that should be considered to mitigate potential impacts associated with the project?
4. Describe the sample route permit for high voltage transmission line projects and explain how the applicants will be required to construct and operate the project in accordance with all conditions of the permit, if issued. The Commission can consider the addition of special conditions to a permit to address specific project concerns or impacted resources in the project area. The Commission will accept comments from the public on the need for and type of special conditions that may be appropriate to include in a permit. To help the Commission decide if it should consider special conditions, please consider providing information to help answer the following questions:
  - a. Are there potential human and environmental impacts of the project for which adequate measures, including mitigation, have not been proposed to reduce or offset those impacts?
  - b. If yes, describe special condition(s) the Commission might include in a permit to offset these impacts.
5. Respond to questions raised by the public. Any verbal comments you make at the public meetings will become a part of the record. You may also submit written comments for the record.

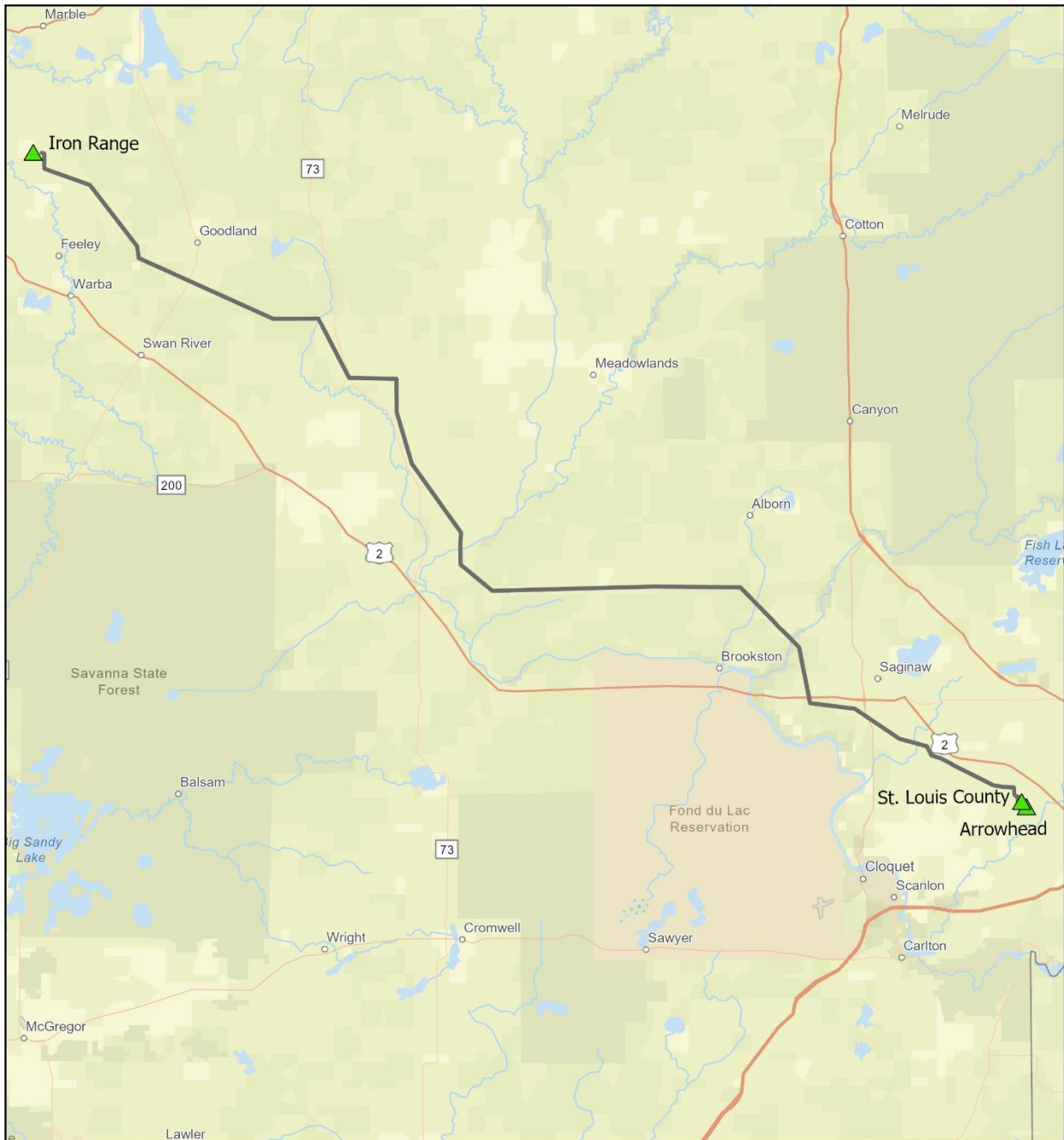


### Project Overview Map
